Contract Agreement

We want you to enjoy the use of our vehicles. We want to ensure that the integrity of our vehicles is maintained for future business. Therefore, these rules apply to all transportation provided by Sherwood Park limo LTD with no exception.

Please check inside the limousines before you enter to make sure that there no damage. If you do not tell the driver or an employee of Sherwood Park limo LTD, you will be charged. So please check!

Sherwood Park limo LTD agrees to provide the designated vehicles and a driver at the time, date and location specified on the contract signed by the customer(s). Unless specified on the contract, request for additional hours will be provided only if the vehicle is not scheduled for other work. Number of the passengers allowed in the vehicles will be no more than specified number in the contract or limited to the vehicles passenger capacity it is designed to carry. Sherwood Park limo LTD reserves the right to substitute a vehicle of equal or greater value in the event of mechanical difficulties or scheduling reasons. Sherwood Park limo LTD and Sherwood Park LTD employees are not responsible for any unattended, forgotten, left, lost, damaged or stolen articles in the vehicles at any time. The sale or use of ILLEGAL DRUGS or smoking in the vehicles is strictly forbidden. Also, alcohol possession or consumption by under aged customers is strictly forbidden. There will be no standing out of moon-roofs or hanging out of windows. Sherwood Park limo LTD is not responsible for the delays or mechanical difficulties caused by weather , traffic condition, mechanical problems, airlines and/or airport problem, airline problems, automobile accidents caused by other, or act of nature. Customers can not attach or fix anything to the interior or exterior of the vehicles or special cleaning, and any loss of income due to negligence or carelessness caused by any member of custom's group, or customer (examples: vehicle damages caused from smoking, burns, tears, vomiting, scratches, broken glassware\utensils, stains , wrestling in vehicles, kicking window\mirrors, and etc.....) and authorizes Sherwood park limo LTD to charge the guaranteeing credit card for the expenses regardless and in addition to any prior understandings and agreements. If the guaranteeing credit card isn't able to be charged, the customer (s) agrees to pay for damages within seven days from the event date. These charges are necessary due to the high cost of damages within seven days from the event date. Customer agrees to pay for any collection expenses and \ or attorney fees and costs associated with Sherwood Park Limo's collection effects. Overtime will be charged at contracted rates when available. In the occasion of "emergency" overtime, the client will have the choice of being dropped off at the first safe area (such as a gas station), or agreeing to pay emergency overtime rates which could be as much as 10 times the contracted hourly charge. These rates will be charged by the minute to make up for the negligence of our limo being late to its next job and discounting or refunding charges to the next client. If you wish to cancel, notify us at 2 weeks before the booking date to get a refund. If notified less than 2 weeks before the booking date, the deposit will not be refund.

- There is a \$20.00 fee per broken/or missing glassware.
- There is a \$750.00 minimum fee for any damage done to the exteriors.
- There is a \$175.00 fee to shampoo/disinfect for damage done by customer. (Includes steam cleaning due to smoking).
- There is a \$500.00 fee minimum for each act of vandalism (Including burns, tears, and holes to upholstery).
- There is a \$100.00 fee minimum for extensive cleanups.
- There is a \$500.00 minimum fee if any T.V or Stereo, and/or any other electronics are damaged.

- There is a \$500.00 minimum charge if the bar is damaged (amount depends on damage done).
- All other damage done will be paid by the customer due to the amount of damage that is done.
- There is a triple charge for each of the items and others above if anything is stolen.

Failure of customer(s) to comply with these terms & condition will result in cancelation of service, requiring payment in full with no refund.
